ZONING ORDINANCE MAP AMENDMENT (REZONING)

Procedural Manual

WHAT IS REZONING?

A rezoning is a change in the zoning district classification of a specific geographic area on the zoning map.

WHEN ARE REZONINGS REQUIRED?

A rezoning request can be initiated by a landowner, City Council or Planning Commission to accommodate a different land use than is permitted in that district.

WHO APPROVES A REZONING?

Rezonings are reviewed by the Planning Commission at a public hearing, following which they make a recommendation on the amendment. Amendments are adopted by the City Council, after considering the Planning Commission recommendation, Public Hearing comments and approval standards.

STANDARDS FOR APPROVAL

The City Planning Commission and City Council shall consider the rezoning request in accordance with the following standards:

- The use requested shall be consistent with and promote the intent and purpose of the ordinance.
- The proposed use will ensure that the land use or activity authorized shall be compatible with adjacent land uses, the natural environment and the capabilities of public services affected by the proposed land use.
- The land use sought is consistent with the public health, safety and welfare of the City of Caro.
- The proposed use is consistent with the City Land Use Plan or a determination that the plan is not applicable due to a mistake in the plan, changes in relevant conditions or changes in relevant plan policies.
